Workers are fighting back

The justices of the Supreme Court of the United States are ruling on two important decisions that will have as major an impact on American working families as never before in contemporary history, that will dictate the future of organized and nonunion labor for many years. These rulings are a result of, and

further proof of, the anti-union, anti-worker war that is being waged by Corporate America and is showing its ugly face on our current Supreme Court. All branches of the US government, including the courts, have a duty to protect everyday Americans from ruthless corporations; it seems they have forsaken this trust. The democracy we have enjoyed for years is seriously at risk, sisters and brothers.

The first anti-worker decision, called Murphy's Oil v National Labor Relations Board (NLRB), was argued in October of 2017 and passed several weeks ago, taking away the rights of workers to band together to sue their employers for wage theft, overtime violations, and other infractions at the workplace. This change by the majority Republican-appointed conservative Supreme Court will affect about 60 million workers in the USA, most of them nonunion. Now nonunion companies can force new employees to sign mandatory arbitration agreements that contain "class action waivers", taking away their "con-

certed protected rights" which had been guaranteed by the NLRB since 1935.

Historically, the NLRB has always ruled that all workers are guaranteed the right to organize together for mutual protection against an employer without getting fired or harassed, and to bring charges against an employer for committing unfair labor practices (ULPs) on the job, whether it be unfair working conditions, wage theft and overtime violations, firing people for trying to organize, and other labor law infractions. When the case was presented to the Supreme Court, the Trump administration's Solicitor General's Office argued on the side of the corporation (!) and against the workers.

The second decision, Janus v AFSCME Council 31, is outright union-busting at its worst. If passed, this decision would break public sector unions in America by allowing employees to refuse to pay union dues, creating an "open shop" situation for all unions in the public sector. A decision will be forthcom-

There were other speakers there who had very inspiring stories, but theirs were personal stories about themselves, rather than about the importance of being a member of the UFCW.



l'm confused! How do I know which 1445 scholarships I should apply for?

STUDENTS!

Are you a high school senior or undergraduate student or thinking about going back to school?

Then read on! If not, you can stop right now.

Are you, or one (or both) of your parents or grandparents, a member or retiree of Local 1445? Then read on! If not, sorry, you're not eligible.

OK, so now you know you're eligible for something, but what? Read on...

Are you a high school senior?

Are you going on to college or university? Then you're eligible for the Nicole Berman, Beppie McNally, and Dennis Norton scholarships. Fill out the "UFCW Local 1445 2018 – 2019 Scholarships" application. You're also eligible for the "UFCW Local 1445 Essay" scholarship, just be sure to include an essay with your entry.

When you graduate from high school, will you be attending a vocational program instead of a degree-granting program? Then you should fill out the "UFCW Local 1445 2018 – 2019 Scholarships" application (same as above) but make sure you check the "Vocational program" box and indicate what type of program you'll be enrolled in.

The "UFCW Local 1445 2018 – 2019 Scholarships" application will enter you in the drawings for three scholarships: the Nicole Berman scholarship, the Beppie McNally scholarship, and the Dennis Norton scholarship. There are two awards for each of these three scholarships: one for \$1000 and one for \$500. The Essay scholarship has two awards of \$1000 each.

Are you an undergraduate student?

Then you should fill out the "UFCW Local 1445 2018 – 2019 Scholarships" application; you are also eligible to enter the drawings for the Nicole Berman, Beppie McNally, and Dennis Norton scholarships.

MEMBERS GOING BACK TO SCHOOL!

If you are a MEMBER who has been out of school and was not a student in 2016 or 2017, but you have decided to go back, Local 1445 may be able to help you out. Fill out the "UFCW Local 1445 Lottery" scholarship application (page 11.) One member who is NOT a high school student or undergraduate student will be chosen for this \$1000 award. This is for MEMBERS ONLY and is for members who have been out of school for a while.

What about families with multiple Local 1445 members?

If you are an undergraduate student or high school senior and YOU are a member, you can send in an application for yourself. And if one or more of your parents and/or grandparents is also a member, each one of them (each Local 1445 member, that is) can send in an additional application for you! So, for instance, if you're a member and both your parents are members, then you could have 3 applications sent in for you – just make sure that each application has the member's name on it as the qualifying member but that all the applications list YOU as the student. Ordinarily if only one family member – student or parent - is a Local 1445 member we could accept only one application for the student; however, in the case of families with students and/or parent(s) who are all members, we can accept multiple entries. Lucky you!!!

UFCW Local 1445 2018 - 2019 Essay Scholarship Application (High school seniors only)

Suggestions regarding essay content

General instructions: This UFCW Local 1445 scholarship will be awarded to college-bound high school seniors who are Local 1445 members, or the spouses, children, or grandchildren of members. Scholarship winners will be selected based on the content and ideas expressed in their essay, and will be announced at the Local 1445 quarterly membership meeting held in July. The person who qualifies the applicant must be a UFCW Local 1445 member in good standing, or a retiree from a Local 1445 employer; applications must be returned to the address on the application and postmarked no later than July 13, 2018.

<u>Students:</u> Your 750 – 1000 word essay should be double-spaced and printed out on single-sided sheets; it should be on the theme "How I Would Convince a Skeptical Friend That *The Union's Got My Back*" (or "...*My Parent's Back*", or "...*My Grandparent's Back*", depending upon who's the union member in your family - you get the idea.)

What should you include in your essay? Think about how you would talk to your friend about the union. Let's say your friend doesn't know anything about unions, only what s/he might have heard from other people. You could explain the history of unions – when they were originally formed in this country, and why: What conditions led workers to organize into unions, even at the risk of being seriously injured or killed by company agents and dishonest law enforcement personnel? What were some of the scandals and tragedies that eventually led to the public support and passage of laws protecting workers and their right to organize, such as the NLRA? Why was it necessary to actually pass laws to guarantee these protections? Then you could describe conditions today: What legal rights do workers have that will help to guarantee living wages, benefits, safe working conditions, and respect on the job? And how do these rights help to protect the American middle class and give everyone a shot at "The American Dream"? What are some of the advantages ALL workers enjoy today – such as overtime pay, days off, paid holidays, etc. etc. etc. –thanks to the Labor Movement? You could add the benefits of being in a union: Unions make sure workers are covered by collective bargaining agreements (contracts) - what's the advantage of that? What's so great about "seniority"? If nonunion workers are treated unfairly all they can do is complain, while union workers can file "grievances" - what's that all about? What's the advantage of having an outside professional representative, i.e., a business agent, to handle any disputes and resolve any problems you or your coworkers might have with your boss? Even if you've never had to contact the union, being a union member means the union is there for you if you ever need help – who can nonunion workers call to protect their interests if they get into trouble? You might go on to explain what's involved in organizing: How do workers at a nonunion employer organize into a union? Can just one person decide to call in the union? Does everyone have to agree? Why would a company object to having workers unionize? Etc. etc.: OSHA is supposed to protect all workers – how is having a union an advantage? And more, such as the fact that a union is completely democratic and all members are considered equal, regardless of where they work or their job description.

These are just some of the points you might want to discuss in your essay – you may have personal experiences you can include or other issues you feel are important to address. All in all, your essay should demonstrate your understanding of the history and evolution of the Labor Movement, and why worker solidarity today will be crucial in the fight to save America's middle class, and why you are proud to be associated with UFCW Local 1445.

UFCW Local 1445 2018 - 2019 Essay Scholarship Application (High school seniors only)

This UFCW Local 1445 scholarship will be awarded to college-bound high school seniors who are Local 1445 members, or the spouses, children, or grandchildren of members. Scholarship winners will be selected based on the content and ideas expressed in the accompanying essay, and will be announced at the Local 1445 quarterly membership meeting held in July. The person who qualifies the applicant must be a UFCW Local 1445 member in good standing, or a retiree from a Local 1445 employer; applications must be postmarked no later than July 13, 2018.

After the winners have been selected and announced, each winner will be notified by his/her business agent and will be required to forward her/his social security number to Local 1445, along with documentation that she/he is a fulltime student at the college or university of her/his choice.

Students: Complete this application and forward it, along with a 750 – 1000 word essay, to the address below. You (or a parent or grandparent) must be a union member; your essay must be on the theme "How I Would Convince a Skeptical Friend That **The Union's Got My Back**" (or "...**My Parent's Back**", or "...**My Grandparent's Back**", depending upon who's the union member in your family - you get the idea) and should be double-spaced on single sided sheet(s). Application forms submitted without an accompanying essay will not be considered. (See the essay guidelines for suggestions on what points to cover.)

IMPORTANT! You may also be eligible for the Nicole Berman Memorial scholarship, the Local 1445 Women's Network/Beppie McNally Memorial scholarship, and the Dennis Norton Memorial scholarship; be sure to fill out and submit the 2018 – 2019 Scholarships Application in order to be considered for those. (But don't worry – if you forget to fill out the additional form, we'll make sure you're entered in those as well.)

These UFCW Local 1445 scholarships will be awarded to Local 1445 members, or the spouses, children, or grandchildren of members. Scholarship winners will be chosen by drawing at the Local 1445 July 2018 quarterly membership meeting from among all eligible applicants. The person who qualifies the applicant must be a UFCW Local 1445 member in good standing, or a retiree from a Local 1445 employer, at the time of the drawing. **Applications must be postmarked no later than July 13, 2018.**

After the winners have been selected, each winner will be notified by his/her business agent and will be required to forward her/his social security number to Local 1445, along with documentation that she/he is a fulltime student or enrolled in a certificate or degree program at the school of her/his choice.

Submitting this application form will qualify the eligible applicant for consideration in the following three Local 1445 scholarships that are awarded by random drawing to high school seniors and undergraduate students: the *Nicole Berman* Memorial scholarship; the *Beppie McNally/Local 1445 Women's Network* scholarship; and the *Dennis Norton* Memorial scholarship.

After the winner has been selected, the winner will be notified by her/his business agent and will be required to forward her/his social security number to Local 1445, along with documentation that she/he is enrolled in a certificate or degree program at the school of her/his choice.

Submitting THIS application form will qualify the eligible applicant for inclusion in the Local 1445 Lottery scholarship drawing, provided the following additional requirements are met:

LEGISLATIVE REPORT

The Fight to Protect Sunday Time-and-One-Half

As 1445 members we know that currently there are only two states in the country where retail and grocery workers by law receive time-and-one-half pay for Sundays and some holidays. Over the past decade this law has been under attack by the Retailers Association of Massachusetts, a special interest group made up of many of the biggest retail businesses, in the state and the country. Over the years Local 1445 and our sister UFCW locals have been able to successfully defeat any legislation filed at the Massachusetts State House that sought



to eliminate this Sunday pay. These attacks on our Sunday time-and-a-half, however, have become more frequent and more serious over the past couple of legislative sessions.

In 2017 during the first year of the current legislative session, the Retailers Association collected enough signatures to qualify a ballot question for the November 2018 elections that would ask voters whether or not they would approve a rollback of the state sales tax from 6.25% to 5%. While the retailers do cite the need to be more competitive with the state sales tax, especially along the New Hampshire border, their actual intention was to use the threat of this ballot question to pressure the legislators at the State House to eliminate Sunday and holiday time-and-one-half for retail workers.

Concerned with the loss of over \$1 billion in revenue for the state budget, legislators began last year taking steps to work with the Retailers to get them to remove their ballot question. In 2017 then-Senate President Rosenberg created the Special Senate Retail Task Force designed to study how the state could help improve the brick-and-mortar retail businesses (that is, those businesses operating out of actual buildings, rather than principally online) in Massachusetts. At first the task force only consisted of business groups, owners, and senators; however, after successful lobbying by Local 1445 we were able to get two labor people on the task force, including Political Director Jim Carvalho, to speak out on behalf of the workers in the industries.

At the beginning of 2018 the legislature invited business groups and members of the community and labor coalition, Raise Up Massachusetts, to meet and negotiate in an attempt to legislatively come to an agreement on all ballot questions soon to appear in

November. Jim Carvalho was elected by Raise Up Massachusetts to be one of the key negotiators at the table, and after several sessions Raise Up Massachusetts stepped back from the table because the business proposals were unacceptable and would harm too many working people in the state. It is clear the main priority for the legislature in these negotiations is to get the Retailers Association to remove their sales tax ballot question and save their budget from losing over \$1 billion a year. Unfortunately, the Retailers have stood firm and would not do this unless they got a complete repeal of Sunday and holiday time-and-one-half.

As many of you know, this is an ongoing bone of contention between Massachusetts workers and their employers, and we continue to put pressure on the legislature to protect time-and-a-half, as we have in the past. Unfortunately, this time around we are dangerously close to its elimination as elected officials, desperate to save their tax revenue, appear ready to make a deal with the Retailers Association. Every UFCW local in Massachusetts has been asking their members to call the Senate President and Speaker of the House, and we have been flooding their offices with calls to protect Sunday Pay. On June 13th we rallied at Downtown Crossing in Boston, then marched up to the State House to deliver a letter on behalf of the more than 300,000 retail and grocery workers in Massachusetts who benefit from Sunday time-and-a-half, and UFCW political directors and leadership have been meeting with legislators to educate them on the importance of this pay, and urge them to not take the drastic step of eliminating it.

While at the time of this writing there has been no resolution, Local 1445, our fellow Massachusetts locals, and our allies in labor and our communities continue the fight to protect time-and-one-half. Thank you to all who have stepped up and come to the rallies, made the phone calls, and spread the word! Sunday time-and-one-half is not something we can afford to take for granted. We need to make sure our elected officials appreciate that Sunday time-and-one-half is essential for many Massachusetts workers and their families, and that if our representatives won't stand up for us against the Retail Association's greedy ploy, we won't stand up for them come election time!

ing any day now and, if passed, will be **the first national union-busting law in our history**. Union funds to negotiate and fight for good wages will be compromised by a lack of funds if unions are prohibited from collecting even "agency fees" going forward; union dues provide the means for unions to stand up to corporations in protecting their members' rights. **This blatant attempt by corporate interests is aimed at stripping unions of their income and, in turn, stripping them of their political power.**

The good news is that the threat of this decision is driving employees in the public sector into becoming active in their unions. Look at current events: 35,000 teachers in West Virginia walked picket lines for 9 days to win better pay and to fix their broken health care system, and won; in Oklahoma, teachers have hit the bricks with the same frustrations as West Virginia and they are fighting for a budget that includes increased funding for education; in Kentucky, the legislature is proposing cuts to teachers' pension benefits, retirees' cost-of-living increases, and their healthcare benefits, potentially sparking a state-wide strike if successful; in Arizona, the overworked and underpaid school teachers who ranked 43rd lowest in the country for teachers' salaries started a #REDforED campaign, wearing red to show solidarity and engaging in collective rallies to protest Arizona's lack of priorities when funding their educational system, and many of them are talking about striking if things don't change soon.

One positive outcome from these attacks on workers' rights is that people are getting active and fighting back. Even some public sector employees who don't have the right to strike are willing to take the risks and strike anyway! Workers are also becoming more politically active and running as candidates in local, state, and federal elections. A spirit of resistance to negative trends and events is growing across the nation. We in the Labor Movement need to provide direction, leadership, and organization to this long overdue resistance.

We need to change the political climate by electing proworker candidates and to require that the Supreme Court do its job of protecting everyday working people, instead of siding with the powerful corporations that are rapidly destroying our middle class and, ultimately, our American democracy.

Basically, boiled down to just a few words, it means you are guaranteed the respect and dignity you have earned as a union member and a hardworking employee at your facility. And your employer had better abide by your contract, because you have your union - Local 1445 backing you up 100%.

In return, one of your responsibilities as a union member is to pay union dues each week. Not only does this small investment produce large returns in the form of contract protections and guarantees, it also means that you have many additional benefits not

specifically spelled out in your contract. You can take advantage of the many programs available only to UFCW UNION MEMBERS, many of which are available to your family members as well.

For example, one important program for UFCW members and their families is the Free College Benefit. You, or your spouse or your children or your grandchildren, can save THOUSANDS of dollars by earning an associate's degree free and online. (See page 6 for more information.) As a working Local 1445 member, you probably have plenty of other day-to-day expenses; union membership can even help with those through UnionPlus/Union Privilege, a nonprofit organization that provides consumer benefit programs exclusively to union members and retirees, and their families.

AT&T wireless plans and accessories; movie tickets; legal help; moving expenses; restaurants; various medical plans; financial help; even veterinary services! And you don't even need a UnionPlus credit card to take advantage of these discounts – all you need is UNION MEMBER-SHIP.

As I said, union membership by itself, with the protection of your legally binding contract, and your Local 1445 representatives to see that it's enforced, is well worth the money you pay in union dues each week. But that's not all your dues are making available to you – there are so many other benefits that are all part of the union membership package. Take advantage of as many as you can - that's what they're there for!
