#### Last Chance for Local 1445 Scholarships for 2021

Every year, UFCW Local 1445 awards thousands of dollars in scholarships to our members and their family members. We have continued to administer the Local 15/John G. Silva scholarship which is awarded to two Gloucester High School seniors; we also award two scholarships to college-bound high school seniors through the Massachusetts AFL-CIO, based on high scores on the labor history exam given to applicants every February at high schools throughout the state.

In addition, Local 1445 awards seven more scholarships at the July quarterly membership meeting. Members or the children or grandchildren of members who are college- or vocational school-bound high school seniors or undergraduate students are eligible; there's also a scholarship for members who are not currently in school but who have decided to resume their education.

The John G. Silva and Massachusetts AFL-CIO scholarships have already been claimed, but there is still time for interested students to apply for the scholarships that will be announced at the July quarterly meeting – the application <u>deadline</u> is <u>JULY 15!</u> More information and applications are on pages 8 and 11 – 12, and if you have any questions you can call Linda at 800-439-1445, extension 101 or email LFerrazzara@ufcwlocal1445.org.

Speak to your business agent, or call the Local 1445 office (1-800-439-1445) and we'll be happy to help you. t was in February of 2020 that the first cases of COVID-19 began to crop up in New England cities, and in early March of that year WHO, the World Health Organization, declared that the world was in the grips of a global pandemic.

From the very first sign that this pandemic would mean serious trouble, Local 1445 did what we do best:

Mobilized all available resources to ensure the best defense possible for our members and their families.

- The Local 1445 Executive Board immediately approved a \$75,000 fund to help those experiencing severe financial hardship by initially providing weekly payment assistance, and continuing food donations up until the beginning of 2021 when conditions began to improve.
- Local 1445 immediately and successfully lobbied Governor Baker and the Massachusetts state legislature to classify our members as "essential" in order to ensure that they would receive every benefit and consideration approved for this classification of workers, including mandated employer-provided masks.
- Local 1445 pushed employers to improve health and safety standards

and to provide protections such as plexiglas shields, hand sanitizer stations, gloves, store occupancy limits, area sanitation supplies, and more.

- Local 1445 campaigned, and was successful for a time, in negotiating with employers to pay "hazard pay" to our members who were risking their lives, and the health of their families, by showing up for work every day. Our members essential workers were making sure their communities had the services and products they needed, in the midst of the global pandemic and in spite of the fact that exposure to a deadly virus was a daily threat.
- And when COVID-19 vaccines became available, Local 1445 got right up in Governor Baker's face

## "Scan and Pay" App Case Shows the Power of Standing Together

Local 1445's recent Scan and Pay mobile app victory underscores the power of being a member of our union family. Our union recently announced that it had won its case against Macy's to reverse the company's practice of using its "Scan and Pay" mobile app to deny commissions to employees on in-store purchases. In this case, which was led by Local 1445, Macy's was found to have violated the rights of Macy's members and was ordered to provide back pay to all workers who lost commissions on in-store sales through the Macy's app.

Key findings of the independent arbitrator in our union's case against Macy's include:

- Macy's Scan and Pay payment system bypassed the traditional point of sale register-based tracking of sales and commissions mechanism, thereby affecting and reducing the earnings of commissioned sales employees.
- Macy's, in effect, instituted an app that constituted a parallel, in-store point
  of sale, without regard to its effect on the compensation of certain commission
  employees.
- Macy's violated the collective bargaining agreements of all UFCW Local 1445 Macy's employees by adopting a new in-store payment model that altered the parties' practice with respect to accounting for and tracking, as well as earning commission credit for, in-store sales.
- Macy's is now required to provide a monetary remedy to demonstrate that the new app violated the parties' collective bargaining agreements by failing to recognize the disruption of the parties' in-store point of sales practice and deal with the corresponding impact on sales associates' commission compensation.
- Effective immediately, all commissioned departments should be excluded from the app, meaning that products purchased from those departments must be rung up by an employee at a register. This will ensure that there are no further incidents of Macy's using the Scan and Pay app to deny commissions that employees have earned.

This victory underscores the value of being a member of our union family. It also underscores the value of continuing to talk about the power of a union contract with your friends, neighbors, and community members, detailing how unions protect good-paying jobs across New England. Together, we can continue to make our union better and stronger.

#### **SECRETARY-TREASURER'S REPORT**

### Unions were here before, they are here today, and they will be here tomorrow

For the past 19 years, I've heard that unions are dying; I'm sure you've also heard, at some point, that unions aren't needed anymore.

Nothing could be further from the truth! On a daily basis, the fights that the union staff take on show how important it is for the union to still exist.

Last year when our president, Fernando Lemus, took over, we focused on restructuring two things in our local union: The first was the renewed com-



mitment to aggressive organizing, which resulted in Local 1445 winning an award for organizing the most members of all UFCW locals in the country. The second was to make sure we restructured how our agents serviced our members, by giving our agents a lot more training and tools, and by adjusting their schedules. We also provided software to create and track data that could be used to back up the results of all the restructured plans and evaluate these.

The chart below is a testament that unions are important and are still needed to this day. The numbers below are from January 2021 to June 17th only!

# UFCW Local 1445 2021 - 2022 Lottery Scholarship application (MEMBERS ONLY – see important note below for application information for family members\*)

This UFCW Local 1445 scholarship will be awarded to Local members who are NOT currently in school but who have decided to resume their educations. Scholarship winners will be chosen by random drawing from eligible applicants at the Local 1445 quarterly membership meeting held in July. (\*Please note: Graduating high school seniors who will be attending a vocational school program, rather than a college or university, are also eligible to enter this lottery but they must fill out and submit the "2021-2022 Scholarships" application form rather than this one.)

The applicant must be a UFCW Local 1445 member in good standing at the time of the drawing. **Applications must be postmarked no later than July 15, 2021.** 

After the winner has been selected, the winner will be notified by her/his business agent and will be required to forward her/his social security number to Local 1445, along with documentation that she/he is enrolled in a certificate or degree program at the school of her/his choice.

Submitting THIS application form will qualify the eligible applicant for inclusion in the Local 1445 Lottery scholarship drawing, provided the following additional requirements are met:

- Applicant is NOT CURRENTLY a student, WAS NOT a student during the last regular school year (2020-2021), and has decided to resume her/his education by attending a vocational/certificate or undergraduate program in 2021; AND
- Applicant is a member in good standing of Local 1445 at the time of the lottery drawing.

\*IMPORTANT! If you are a high school senior who will be attending a vocational school (rather than a college or university) upon graduation please be sure to fill out and submit the Local 1445 2021 – 2022 Scholarships application NOT this one, as noted above. #### **POLITICAL/LEGISLATIVE REPORT**

## After weeks of sitting on Gov. Baker's desk, emergency paid leave policy becomes law.

Over a month ago the state legislature passed a bill that would provide emergency paid leave for COVID-19 related issues. Both public and private sector workers would be eligible for up to five days of paid leave for COVID-related illness or vaccine-related side effects for one's own self, family, or member of the same household.

In April Governor Baker sent the bill back to the legislature excluding municipal workers from coverage. Local 1445 and the AFL-CIO fought to include municipal workers. As a result, the House and Senate rejected the Governor's changes.

This policy is in addition to the state's 2014 paid family leave, and the federal paid leave passed last year during the height of the pandemic. The new policy would cover gaps in the existing state and federal laws.



In May Massachusetts received \$5.2 billion in COVID relief federal funds. These funds are now under the control of the Executive Office for Administration and Finance. As it stands now Governor Baker unilaterally controls this money without legislative oversight or appropriations.

Speaker of the House Ron Mariano and Senate President Karen Spilka issued a joint statement indicating the federal funds should be moved into a separate account. The Secretary of Administration



and Finance would still have control over the funds, but the legislature would authorize the spending of the money.

UFCW Local 1445 President
Fernando Lemus wasted no
time and penned a letter to
Governor Baker requesting
a meeting regarding the disbursement of the billions of
dollars of these federal funds.
Additionally, along with our sister UFCW locals and the Massachusetts AFL-CIO, specific
proposals for hazard pay for
Local 1445 members have
been developed and offered
for consideration.

## Infrastructure bill is the next test for the Biden Administration

President Biden is negotiating with Republican leaders to hammer out a trillion dollar infrastructure bill that would create millions of good jobs to repair our crumbling roads, school buildings, parks, water systems, public transportation, and provide access to childcare and high-speed internet.

Chief Obstructionist Senator Mitch McConnell is trying to narrow the definition of "infrastructure" and repurpose already appropriated COVID relief funds for a much more modest infrastructure bill.

#### **VICTORY!: "Right to Work" bill DEFEATED in NH**

After months of grassroots organizing and legislative advocacy the so-called "Right to Work" bill, that would have weakened private sector unions as well as take away worker protections under the National Labor Relations Act, was defeated soundly. Local 1445 member and shop steward Cheryl Ferullo testified against the bill before the Labor Committee. Alan Raff of the NH AFL-CIO and 1445 member coordinated the efforts by the state's labor movement to defeat the bill. Brother Raff was also recently elected to the NH AFL-CIO's Executive Committee. Congratulations to the NH AFL-CIO and workers from all sectors.

#### **Fair Share Amendment goes to the Ballot**

The MA Legislature voted 159 to 41 to advance the Fair Share Amendment to the November 2022 ballot. The vote was 121 to 39 in the House and 38 to 2 in the Senate.

The Fair Share Amendment would amend the Massachusetts Constitution, creating an additional tax of 4 percentage points on the portion of a person's annual income above \$1 million. This new revenue would be invested into funding our public schools and colleges as well as the repair and maintenance of our roads, bridges, and public transportation infrastructure.

Although today's vote was exciting, the work isn't over yet. *It's just beginning.* In the coming months, we'll keep you posted about ways to help ensure a victory for Fair Share in November of 2022.

After the winners have been selected and announced, each winner will be notified by his/her business agent and will be required to forward her/his social security number to Local 1445, along with documentation that she/he is a fulltime student at the college or university of her/his choice.

**Students:** Complete this application and forward it, along with a 750 – 1000 word essay, to the address below. You (or a parent or grandparent) must be a union member; your essay must be on the theme "How I Would Convince a Skeptical Friend That *The Union's Got My Back*" (or "...*My Parent's Back*", or "...*My Grandparent's Back*", depending upon who's the union member in your family - you get the idea) and should be double-spaced on single sided sheet(s). Application forms submitted without an accompanying essay will not be considered. (See the essay guidelines online for suggestions on what points to cover.)

**IMPORTANT!** You may also be eligible for the Nicole Berman Memorial scholarship, the Local 1445 Women's Network/Beppie McNally Memorial scholarship, the Dennis Norton Memorial scholarship, and the Joe Hayes Memorial scholarship. #### **CONTRACT NEGOTIATIONS REPORT**

### Stay Strong - Stay Involved

UFCW Local 1445 has had many, many contracts expiring lately, so we've been going all out to negotiate HARD with these companies to make sure our members get the very best contracts with as many improvements as possible! This isn't always easy as the companies do not want to take care of their employees. Now that the pandemic seems to be on the wane and things are starting to get back to "normal" (whatever that is!) this is NOT the time to relax and take things easy; this is NOT the time to forget all the risks and concessions **YOU** made for your employers so they could stay in business and would still be up and running once the pandemic restrictions had been lifted. It's a good bet that your employers would like you to forget all that you did for them, but your union – Local 1445 – is not about to let that happen!

We have ratified excellent contracts with Macy's/ Saugus, Crothall, and The Reservoir Nursing Home, and next on the agenda are Westwood DPW, Norwood Healthcare, and Bob's Discount Furniture. We are also working to negotiate strong contracts for our new cannabis units. And don't forget about Stop & Shop! That contract will be expiring very soon and I'm sure we all remember the fight we had with the company three years ago. That was one for the history books, with the outstanding participation of our members, our fellow unions, our communities, and our labor-friendly elected representatives. That was a clear demonstration of the **power of solidarity**, and Local 1445 members must be ready to always use that superpower to support all our union sisters and brothers, no matter where they work or what they do.

If your contract is due to be renegotiated soon, make sure you are ready to join with your coworkers in the battle over the big issues: wages, benefits, a safe workplace, health insurance, pensions, and more. Think about what's important to you, and speak up! Make sure your negotiating team KNOWS what you expect from them, and be ready to fight if necessary.



Maybe your contract has already been negotiated. You can relax a little bit but don't forget that before you know it, it will be time to renegotiate. It's never too soon to plan ahead and prepare for that time by thinking about what you'd like to see in the future. Be involved, get in touch with your business agent with your questions and concerns. Be a part of your negotiations.

UFCW Local 1445 members have contracts - legally binding documents – that protect them from being taken advantage of by our employers. That's an invaluable benefit, but a contract is only as good as the members who will stand behind it and stand up for their coworkers. If you have questions about your contract, don't be afraid to contact your business agent – that's their job. If you see contract violations, again, contact your business agent – that's their job. And always support your union sisters and brothers - stay strong and stay involved. As union members, that's YOUR job!

#### Uber and Lyft start a well-funded campaign to reclassify employees as "independent contractors"

In California, Uber and Lyft provided funds of \$220 million to get Proposition 22 passed in the ballot. As a result, thousands ation and UFCW Local 1445 at St. Vinof workers lost their rights under the federal Fair Labor Standards Act, the National Labor Relations Act. and California state labor laws. One example was that hundreds of **Peapod drivers** were fired from supermarkets because they are now "independent contractors".

Uber and Lyft have set their greedy eyes on Massachusetts to do the same either by ballot and/or legislation. This will not only affect "gig drivers" but entire categories for employees including in healthcare. education, construction, and retail sectors.

#### Cannabis Workers' Right to **Organize Update**

Drafted by Local 1445 and introduced by Representative Steve Owens (D-Watertown) and Senator James Eldridge (D-Middlesex/Worcester) H. 3710 and S. 69

respectively "An Act to facilitate the unionization of the cannabis workforce" has been referred to the Joint Committee on Cannabis Policy. The Senate Chair of the Committee is labor's strong friend Sonia Chang-Diaz (D-2nd Suffolk). The House Chair is Representative Daniel Donahue (D-16th Worcester) who has walked the picket lines of the Mass. Nurses Associcent's Hospital.

The bill would establish as a condition of licensure that a Labor Peace Agreement (LPA) with UFCW 1445 be in place. The LPA would basically require the employer to remain neutral during an organizing drive. Similar arrangements are known as Project Labor Agreements (PLA) in the Building Trades.

UFCW represents thousands of cannabis workers throughout the nation, and Local 1445 represents hundreds of cannabis workers in the Commonwealth of Massachusetts from grow facilities to medical and recreational retail. Industry experts project that the cannabis industry in Massachusetts will grow to over a billion dollar industry in 2021! We must make sure that these are union jobs with Local 1445 benefits, protections, and representation. We will keep you updated of any new developments and dates for hearings.

#### **President Fernando Lemus**

has been named by the Massachusetts AFL-CIO to Chair of the Campaign to Protect Workers' Rights to fight against the Uber and Lyft ballot initiative and legislation. The UFCW International and the UFCW New England Council are also supporting the campaign. Political Director Gabe Camacho has already made several presentations to unions and community organizations to join the fight, because when we fight, we win! In the coming weeks we'll keep you posted about ways to ensure a victory for all workers in Massachusetts.
